Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of appropriate authority for recognition of your school from 1st to 8th level (without aid) w.e.f. the session 1997-98 subject to the fulfillment of the following terms and conditions:

1. That the school shall abide by the provisions of Delhi School Education Act, 1973 and rules framed there under as well as the instructions issued from time to time by the Department.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall purchase adequate science lab., equipments and apparatus as per the norms of Education Deptt.
4. That proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per students shall be purchased and made available to the students.
5. That adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the provisions of Section 10(1)(a) of the D.S.E.A & Rules, 1973.
7. That the school shall not run any un-recognised classes ^{or} any non-educational activities within the school premises and all the ~~xxxxxxxxxxxx~~ recognised classes ^{be run} at the one place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
8. That the school shall dispense with the services of un-qualified and over-aged staff, if any, immediately.
9. Fresh Health Certificate from MCD be obtained and produced to the Education Officer for verifications.
10. The management of school will obtain land from DDA, if already not obtained in the name of the Society through Director of Education, Delhi and shall construct the school building thereon for the school as per specifications of the Department within a period of two years. That adequate and sufficient accommodation of 10 sq.ft. per student shall be provided for the class room, but no class room shall be less than 15' x 20' sq.ft. area.

11. That proper facilities for drinking water, toilets and aid be provided. Separate toilets for boys, girls and ate toilets for ladies and gents staff be also provided
12. That the school authority will apply for P.F. facilities the Provident Fund Commissioner and will provide the staff in proper manner.
13. That the Managing Committee of school shall not increase enhance fee during the ensuing academic session without prior approval of the Director of Education which is mandatory requirement under sub-section (3) of Section 17 of Delhi School Education Act & Rules, 1973.
14. That all the facilities prescribed under rule 50 and 51 Delhi School Education Act & Rules, 1973 shall be made available to the students.
15. That 9th class should not be added without the prior approval of the Director of Education.
16. That the management of school shall create a Reserve Fund equal to minimum three months salary of the staff in the Joint name of the Director of School and the Manager of the school or in the form of F.D.R. of Rs. One Lac plus Rs. 80/- per student, whichever is less.
17. The report about the fulfilment of the above conditions shall be sent to the Education Officer within six months
18. The school should not seek upgradation of Sec. classes till it fulfills the norms laid down by C.B.S.E. also
19. The school shall follow the directions of Department regarding fee structure etc
